What is Ubisecure Right to Represent?


Right to Represent allows service providers or government departments to connect to and check a company's verified identity and the rights of individuals to request on behalf of, or represent, the company.

Representation attributes can include legal, financial, administrative or other authoritative powers. Traditionally, such governance has been administrative and, therefore, time consuming and costly. Ubisecure's Right to Represent digitizes that administrative governance to technically implemented governance, making way for automated workflows.

Using the same OAuth 2.0 authorization protocols used for "Sign in with Apple" or "Log in with Facebook", Right to Represent incorporates "Sign in with RapidLEI" to allow Legal Entity Identifier (LEI) based accounts to authenticate organization affiliation and rights.

- Digitize resource-heavy administration tasks such as company spending approval, enforcement and reconciliation
- Make B2B customer onboarding, KYC and AML workflows faster, lower cost, and more effective
- Govern and enforce a representative's legal and financial rights
- Approve an individual's right to transact on behalf of the organization
- Verify an individual's assigned legal representation rights
- Delegate electronic power of attorney to an individual or organization and manage the levels of onward delegation
- Streamline company verification in Certificate Authority, PKI, and electronic signing applications
- Digitize complex government to organization/citizen services

Right to Represent requires a standardized organization identity managed through an identity provider (IdP) & rights delegation service

- Ubisecure’s GLEIF-accredited Legal Entity Identifier (LEI) issuance service, RapidLEI, provides the LEI for the standardized organization identity
- Ubisecure’s IDaaS (Identity-as-a-Service for CIAM) provides the Identity Provider (IdP) and Rights Delegation service

Workflow Overview

Step 1 – Verify Rights



- Individuals request Legal Entity Identifier(s) for organization via Ubisecure’s automated RapidLEI service
- Rights of individual to request and represent on behalf of organization are verified
- Rights and assurances are recorded and managed through the Right to Represent IdP service

Step 2 – Delegate Rights




- Verified individuals can invite other individuals to join through multi-tier system
- Invitees are verified depending on role of the inviter

Step 3 – Assert Rights



- Service providers add Right to Represent authentication (OAuth 2.0) at point in workflow they need to determine rights – displayed as a ‘Sign in with RapidLEI’ login button
- Defaults to a strongly authenticated individual (MFA) and a highly assured organization (LEI)
- Pre-established mandates specify the definitions and values of the rights (legal, financial, administrative)
- Service provider builds assertion conclusion into workflow or product via SDK/API

Advanced KYC should include 'right to request' and 'right to represent' & can be part of every customer onboarding process where identity matters

Business Value of Right to Represent

Right to Represent reduces costs by outsourcing right to request/right to represent workflows. Ubisecure delegation of authority (the engine behind Right to Represent), is being used by numerous European government and telecoms providers.

The Finnish Government needed an identity management system to enable the strong identification of individuals and organizations for online government services that scaled nationwide, and supported online power of attorney. Ubisecure provided the solution, now known throughout Finland as Katso.
