## Delegated ID

Improve efficiency and reduce costs of manually administering multi-tier, multi-organisation users and their rights, with Delegated ID from UbiSecure.

Delegation is often a crucial factor in how effectively an organisation manages digital identity, but getting it right for complicated use cases is a difficult task. What's more, getting it right at a national scale is even harder. UbiSecure has many years of practice in evolving and perfecting its delegation expertise, with multiple proven success stories from major organisations, such as the Finnish government (see Case Study 1 below).

UbiSecure Delegated ID enables you to delegate role management to external customers, businesses or organisations to enable users to act on behalf of other persons in digital services, and authorise others to act on their behalf. Support even the most complex combinations of assignment with delegation of rights, roles and representation from individuals to individuals, individuals to organisations, organisations to individuals, and organisations to organisations.

### CASE STUDY 1: KATSO

The Finnish government built the nationwide Katso platform using UbiSecure Delegated ID. As a representative of an organisation, citizens create a Katso ID online, manage organisation data, manage Sub-IDs and authorisations. Organisation representatives and their staff, or any other authorised third-party, can then log in to over 100 government applications.

- 444,000 user IDs
- 422,000 organisations
- 11+ million sign-in events

## The most flexible delegation solution available today



### — DELEGATED ADMINISTRATION

Allows the organisation to push the workload out of the service provider or helpdesk, to the administrator within the customer organisation, to have the administrator create and manage (sub)accounts on the service. The usual resource-intensive administration of authorisations is not required.



### — FAMILY DELEGATION

Delegated ID extends effectively to family access to digital services, supporting use cases like parental controls, management of family members subscriptions, and legacy planning.



### — ELECTRONIC POWER OF ATTORNEY

Delegated ID operates as a centralised authorisation server, where mandates act like power of attorneys. Delegating users can manage authorisation for delegates (both organisation or individuals) to have authority to represent them on digital services and applications. Depending on the use case, delegates can further delegate to multi-tiers of external users.



### — SUBCONTRACTORS & MANAGED SERVICE PROVIDERS

Granular control of access to systems is extended to subcontractors, consultants and managed service providers. Delegated ID supports the right of a delegate to act on behalf of the delegator for mandated use cases, and under mandated conditions such as contract period, authentication method and workflow, and more. Automatically close access privileges at the end of contract periods.

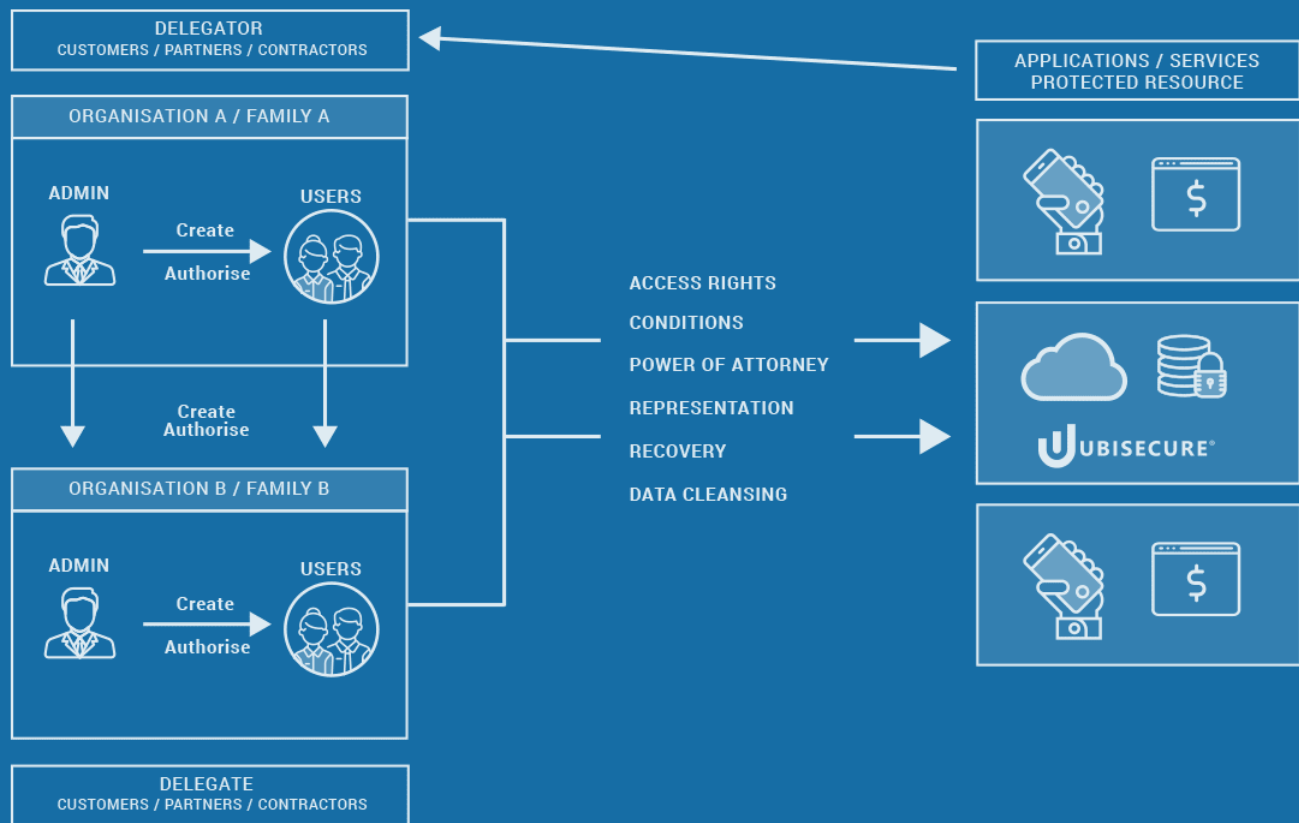


### CASE STUDY 2: VERO SKATT

The Finnish tax authority (Vero Skatt) uses Katso (see Case Study 1), resulting in:

- 1 million transactions per month
- €8 saving per transaction
- 99% reduction in cost by moving to online service vs physical point of service

### CASE STUDY 3: ENERGY INDUSTRY

A large energy company uses UbiSecure Delegated ID to enable the delegation of access to and authority within accounts for B2B customers.

This means that a company administrator can easily assign/revoke permission-based roles to users, so that they can access appropriate areas of the company account. A user who has multiple roles (e.g. a property manager with multiple clients, or an individual with both a private account and corporate representation rights) can select a role before using the service, meaning they still only have one set of credentials to remember.

Reduce fraudulent organisational representation during provision of new services, high risk transactions and onboarding of new customers.

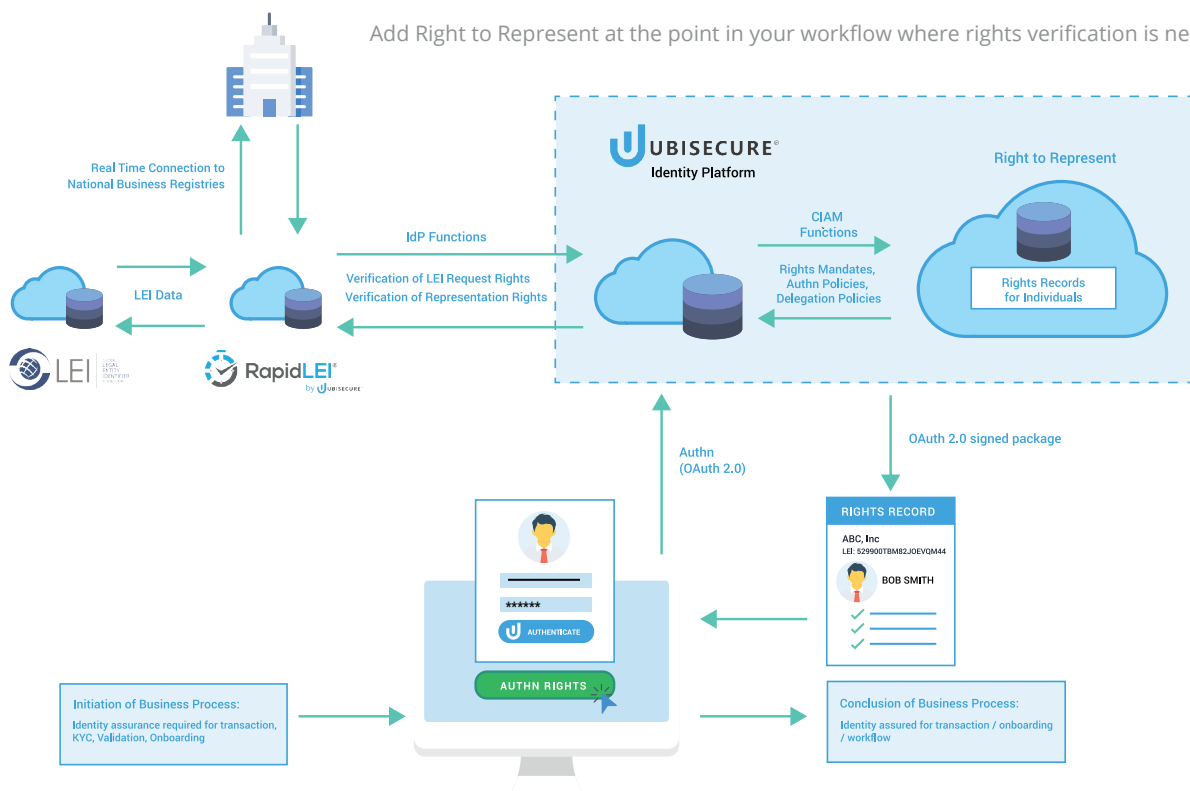
